# **Political Action**

In December 2012, Council president Michael O'Hara Garcia joined growers, marketers and academics from California, Georgia and Texas testifying before the International Trade Commission (ITC) in support of fair trade practices for the U.S. olive industry.

The assembled advocates asked the ITC to investigate unfair tariffs (over 3,000%), high production subsidies (up to 40%) and the mislabeling of imported extra virgin olive oil (a UC-Davis study found 70% of EVOO failed U.S. and international standards for quality).

According to ITC staff, the investigators completed their travel and are in the final stages of gathering information and drafting the final report to be delivered to the US House Ways and Means committee on August 12, 2013. If the U.S. olive industry allegations are substantiated, the Secretary of Agriculture may choose to issue a <u>federal marketing order</u> and begin to enforce U.S. quality standards. This will hopefully help level the playing field. Domestic producers of high quality extra virgin olive oil (EVOO) will not have to compete unfairly against high-priced low-quality imports and mislabeled foreign product.

#### Gainesville

### De Leon Springs



**Richard Williams** and **Alex Ford** established a 20 acre high-density (6' x 13'- 600 trees/acre) grove in July 2012. Cultivars are Arbequina, Arbosona and Koroneiki. Nine other varieties were planted for observation and research. Williams and Ford are incorporating a modern grove management plan using advanced sensors to optimize plant development and control costs.

## Live Oak



**Jonathan Carter** of Florida Olive Farms established a olive grove near the historic Suwannee River last year and has expanded to approximately 33 acres (21,000 trees) of super high density (5' x 13') planting of Arbequina, Arbosona and Koroneiki. Despite some potassium deficiencies resulting from unusually high flooding in Suwannee County this year and some scale; Jonathan is confident of continued success. He is planting another 15k trees this year. Marion County
